Required documents for entrance in Bulgaria:

“According to order N RD-01-416/04.06.2021, amendment order N RD-01-498/1504.06.2021, from the Minister of Health of the Republic of Bulgaria, the temporary control measures concerning the entry on the territory of the Republic of Bulgaria from 05.06.2021 to 31.07.2021, entering person upon arrival is supposed to present **one of the following documents**:

1) Document for completed **vaccination course** against COVID-19. For completed vaccination course is considered the appropriate number of doses of a given vaccine and the expiry of a 14-day period, as of the date of the last dose. The document must contain the following data: names of the person written in Latin, according to the identity document; with whom he/she travels; date of birth; date on which the last dose received was given; the total number of doses for vaccines, which are given twice; the trade name of the vaccine; name of the manufacturer / marketing authorization holder; country of issue and the name of the issuing competent authority.

2) Document showing a **positive result** of a study performed by the method of polymerase chain reaction or rapid antigen test for COVID-19 - for individuals suffered from COVID-19 for the period from the 15<sup>th</sup> to the 180<sup>th</sup> day from the date of the conducted research, entered in the document. The document must contain the names of the person, written in Latin, according to the identity document with which he/she travels; data on the medical institution that performed the examination (name, address or other contact details) or the authority issuing the document; the date on which the polymerase assay was performed by chain reaction or rapid antigen test for COVID-19, written in Latin method (PCR or RAT) and a positive result (Positive or RAT), allowing interpretation of the document.

3) Document showing a **negative result** of held up to 72 hours before entering country study by the method of polymerase chain reaction (PCR) or negative result of a rapid antigen test performed up to 48 hours before entry into the country evidence of COVID-19 as of the date of the study entered in document. The document must contain the names of the person, written in Latin, according to the identity document with which he/she travels; data on the medical institution that performed the examination (name, address or other contact details); the date on which the polymerase assay was performed by chain reaction or rapid antigen test for COVID-19, written in Latin method (PCR or RAT) and a Negative result, allowing interpretation of the document. The rapid antigen test should be listed in Annex 2 of the order.

On the territory of the Republic of Bulgaria may enter without the need to present any of above mentioned documents citizens of the Republic of Romania and Czech Republic arriving from Romania and Czechia respectively.”
